Proceedings:

1. The meeting began with the Vice-Chancellor's address, emphasizing a zero-tolerance policy towards ragging.
2. The Registrar presented the framework based on UGC regulations and summarized last year's performance.
3. Each constituent colleges and SAPHST shared their preparedness reports.
4. The committee approved the formation of College-level Anti-Ragging Committees and Squads.
5. It was resolved that awareness drives, induction orientations, and legal awareness programs will begin from 01-03-2025.
6. The mentor-mentee system was ratified for uniform implementation across all institutions.
7. Surprise checks were scheduled bi-monthly by rotating internal faculty squads.
